Dear Ms. Kitchings:

I am writing regarding an exhibit that I have designated as part of the Record on Appeal in this matter. The exhibit is a ten-foot long PVC pipe that was entered as an exhibit in the contested case hearing before the Administrative Law Court. At the conclusion of the hearing, the ALC instructed my client, Mr. Weatherholtz, to take the exhibit with him. Mr. Weatherholtz did so, and he has since kept the exhibit at his house. He has kept the exhibit protected and has not altered it since the contested case hearing.

Now that the Record on Appeal has been filed, we want to deliver the exhibit to the Court of Appeals so that we can comply with the second sentence of Rule 210(f). Normally, I would ask you to issue a transport order to the ALC under the last sentence of Rule 210(f). However, because Mr. Weatherholtz has retained the exhibit, that sentence does not apply.

We would like to bring the exhibit to the Clerk's office for filing, using either a courier from my office or a commercial carrier. I have spoken with opposing counsel Brad Churdar about this proposal, and he consents to it. Please let me know whether this proposal is acceptable to you or, if not, what alternative procedure you would like us to follow.

Thank you for your assistance on this issue. Please let me know if you have any questions or require anything further.

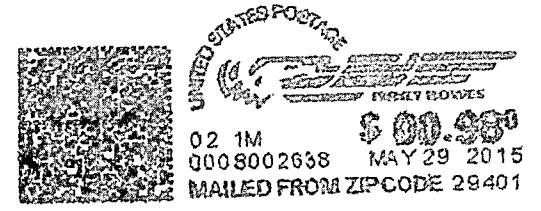
