
Initially, I was told that my appeal had been lost, and then I received notification that I had been assigned a case number and that I needed to obtain a copy of the transcript. Since then,

I was not notified as to what the deadline was for the initial brief to be in due to the fact that I have not received any communication from the court of Appeals in regards to that matter. In addition, as far as the computation of time, my mail gets screened and sometimes withheld for days. So, my computation of time may differ due to the date I actually received the correspondence.

I am essentially petitioning for an extension of time to and including June 30, 2015. I am petitioning for a just reason and not for delay. No one wants this issue heard faster than I do; however I need time to assure that all issues are addressed. This extension is in the best interest of justice due to my lack of freedom, liberties, and resources.

Therefore, I am respectfully demanding an extension of time to and including June 30, 2015; and any and all remedy and relief that is just and proper.



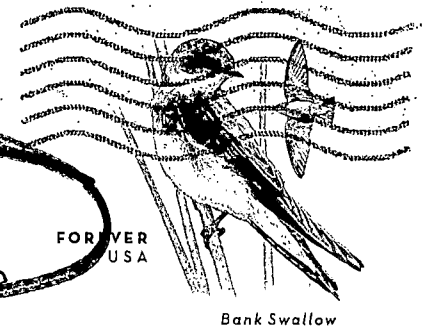

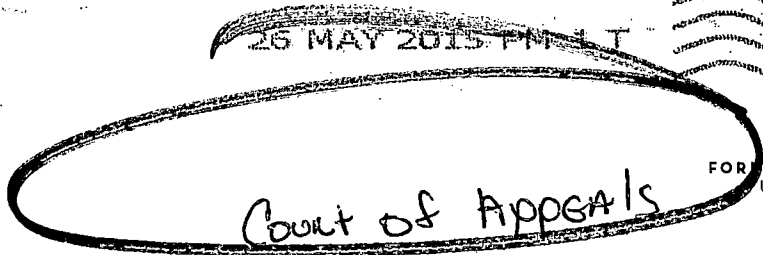
