
**MOTION TO WITHDRAW APPEAL**



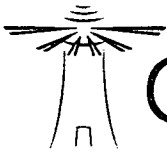
