
Dear Madam Kitchings:

I'm in receipt of Mr. Evans letter dated May 29, 2015, addressed to you regarding Respondent to notify the Court whether or not certain information was presented to the Administrative Law Court (ALC). Please be advise that ALC Judge Durden did not enforce the Respondent to comply with ALC Special Appeals Rule 58, Record After Final Decision, and Rule 61, Record on Appeal. The audio tape within the record does not include the Board Members vote, and the Respondent does not provide such audio tape until 30 or 90 days after the hearing. An inmate has 30 days to appeal the final decision of the Board, and 65 days after the date of assignment to file a brief. SEE: Rules 59, and 60(A).

In addition, I'm not a parolee nor am I a probationer; therefore, I'm not exempt from disclosure as for the Parole Examiner's recommendation, prior supervision history, statements of opposition and COMPAS Assessment Results from my hearing on January 14, 2015. The Respondent has misapplied §30-4-40(a)(4); §24-21-290; and State v. Hook, 590 S.E.2d 25 (2003), along with §24-21-280. Neither have anything to do with a prisoner's pre-parole investigation. SEE: §19-3-120, and §19-5-610, my COMPAS Assessment Results should be transparent for Public Record in accordance to the Evidence Act. Section 19-5-510, Business Records Act, or Evidence Act Exception whereas the information is relevant and competent evidence. The Respondent made preparation of my pre-parole file in the regular course of business. Again, I'm not a parolee nor a probationer and there is no such file that is privileged and exempt from disclosure in my particular case.

Thank you for accepting this letter and including it in the record.

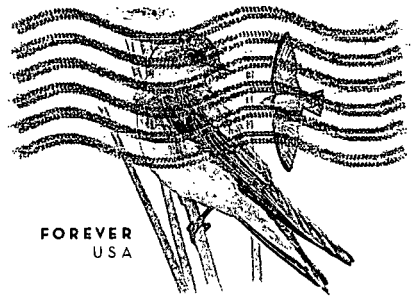

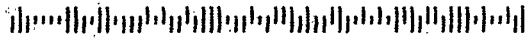
