
INDICTMENT FOR  
ATTEMPTED ARMED ROBBERY

§ 16-11-0330(B)

At a Court of General Sessions, convened on July 27, 2015, the Grand Jurors of Barnwell County present upon their oath:

That **LARRY DENNIS CRADDOCK, JR** along with others, did in Barnwell County on or about April 14, 2014, while armed with a deadly weapon or while alleging either by action or words that he was armed with a pistol or other firearm, attempt to feloniously take from the person or presence of Ramon Perez, by means of force or intimidation goods or monies of Ramon Perez, all in violation of §16-11-330 of the Code of Laws of South Carolina (1976), as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
