

INDICTMENT FOR  
ARMED ROBBERY  
§ 16-11-0330(A)

At a Court of General Sessions, convened on May 25, 2015, the Grand Jurors of Barnwell County present upon their oath:

That **LARRY DENNIS CRADDOCK JR** did in Barnwell County on or about April 14, 2014, while armed with a deadly weapon or while alleging either by action or words that he was armed while using a representation of a deadly weapon or an object which a person present during the commission of the robbery reasonably believed to be a deadly weapon, to wit: pistol or other deadly weapon, feloniously take from the person or presence of Ivan Mercado Valdez by means of force or intimidation goods or monies of Ivan Mercado Valdez, such goods or monies being described as follows: wallet, which held United States currency and identification, all in violation of §16-11-330, Code of Laws of South Carolina (1976), as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
