
MOTION TO ORDER TRANSCRIPT OUTSIDE OF TIME LIMIT

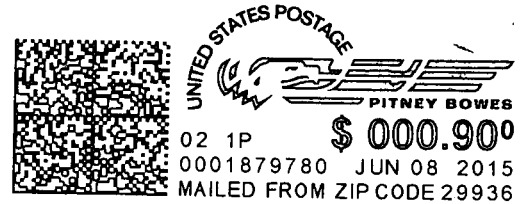
