Please see the attached information. I have called your office and left a voice mail concerning the same.

Today I received in the mail from The South Carolina Court of Appeals an "Order" that my appeal case (Appellate Case No. 2015-000997) has been dismissed for my failure to pay the notice of filing fee as required by court rules. The Notice was filed on June 12, 2015, I received it today, June 15, 2015.
