Dear Ms. Kitchings:

I am writing to advise that the appeal in the above-referenced matter has been transferred to me for further handling on behalf of the Respondent South Carolina Community Bank. I would request that my name be added along with S. Nelson Weston Jr. and Charles J. Webb's as counsel for the Respondent South Carolina Community Bank, and that future documents and correspondence regarding this appeal be directed to my attention. By copy of this letter, I am also requesting that counsel for the Appellant Salon Proz, LLC direct future documents and correspondence to my attention.

In addition, as counsel for the Respondent South Carolina Community Bank, we respectfully request a 30-day extension of time in which to serve and file our Initial Respondent's Brief and Designation of Matter to be Included in the Record on Appeal. The Brief and Designation are currently due on Monday, June 8, 2015. However, with a 30-day extension of time, they would be due on Wednesday, July 8, 2015.
