
Re: Appeal

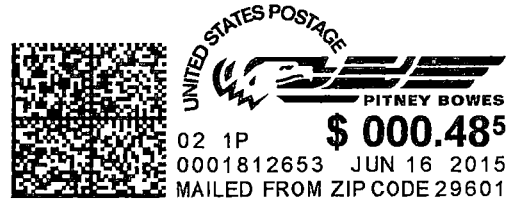
