
Dear Mrs. Kitchings:

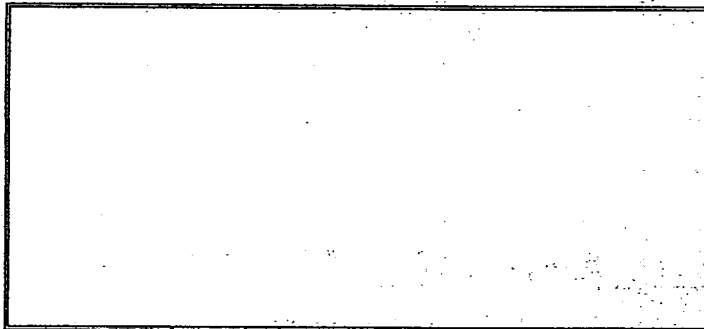

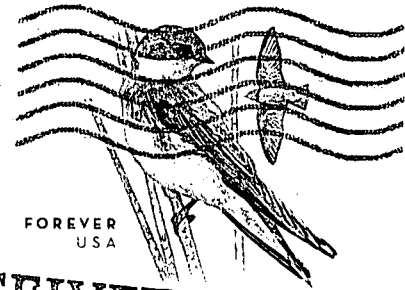
