<Issues for Appeal>

SC Court of Appeals

- ① I Del Carlos Shores signed an open plea with a verbal understanding that my lawyer-Ash Chisholm, solicitor-Don Sorenson and Judge Edward W. Dickson had met in chambers and agreed to a sentence not to exceed 8 yrs. on each charge of Fel. DUI w/ Great Bodily Injury and Fel. DUI w/ Death run concurrently.
- ② Ineffective Council - uncaring to the facts and details of my case, also distant and uncommunicative at any and all meetings. Filed Motion for Dismissal with Cheryl Graham/Clerk for Dorchester County on October 15, 2014 and was denied by Judge Harrington - saying I needed to "give him time to work". After that hearing became even less caring communicative.
- ③ Lawyer - Ash Chisholm - withheld evidence of who was at fault in the accident, which had direct bearing on sentencing. Accident Report withheld states "had the 18-wheeler been doing posted speed limit of 55 mph then the accident would not have occurred.
- ④ Filed several motions with Solicitor - Don Sorenson - that never were addressed by him or courts which would have had direct effect on court proceedings.

## Issues for Appeal

2 of 2

- ⑤ Was under the influence of prescription drugs which affected my decision making process. (Trazodone, Prozac, Naproxen)
- ⑥ Held without bail for almost a year without further bond hearings in Dorchester County Detention Center to try and force me into a position for plea.
- ⑦ Many statements in file of case that are contradictory and not factual when closely examined but had no access to legal materials in county jail or law library.

.... It is my belief that with different counsel on my case and the other matters stated herein that my case may have had a different outcome.

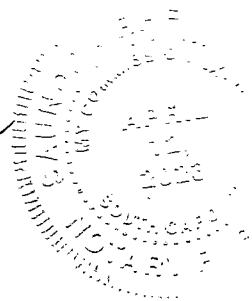

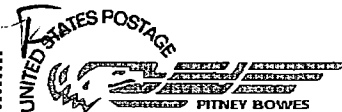
