Per my recent conversation with your staff, I am formally requesting a thirty day extension, and I have enclosed the required \$25.00 fee required to file this motion.

In order to handle my appeal properly, I need to obtain all my medical documentts and any correspondence from DSS, as well as the adult protective service department with in the general organization. Initially I was instructed to obtain all requested items from their offices near the Greenville County family court. However, on the day scheduled to do so, the particular woman I was scheduled to meet with was out of the office and unavailable. I left my contact information, but was not ree contacted . I took the initiative and was finally informed my items had had been placed in storage in another county, and these items would have to be ordered, retrieved, and reviewed in Greenville. After this They promised to send them to me. They did not indicate how long this process would take to be fulfilled. I have checked regularly and it was verified I would be sent all my records and corespondence. This has not happened; accordingly.

Additionally, in as much as my case involved over lapping issues in both the family court and civil court, a number of lawyers were involved, and it appeared to me they were handled by each court seperately during the hearings I attended.

I was not aware of the first hearing nor was I invited. So I don't have first-hand knowledge of those events. Mr. Amos workman graciously met with me during and after the first hearing and was replaced by another young lawyer who during this timeframe became employed by DSS.

And, he has continued to work for them, consequently he can not speak with me any longer regarding the case. Other attorneys are on vacation and have yet to respond to my requests.

The appeal I filed with the Clerk of Court, Mr. Paul B. Wickenshimer is based on fraud, and deceit, and bias. Therefore, I need the written record. to prove my arguments.

Finally, I am aware my Primary Attorney does not agree with my point of view. I respectfully disagree and believe he is mistaken. He expressed to me that I am entitled to my point of view and beliefs in the matters.

I believe in the furtherance of justice, I have no choice but to file my appeal.

I am sincerely appreciative of the court of appeals consideration of my motions.

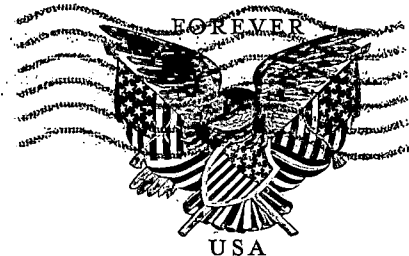
