

Dear Ms. Kitchings:

Please accept and file this letter, which I am writing to respond to the allegations contained Appellant's June 10, 2015 letter to the Court. In that letter, Appellant claims that there have been incidents "that have affected Appellant's ability to properly litigate" this case. Specifically, Appellant claims that an institutional search team "confiscated several [of Appellant's] legal documents." Taking such an accusation seriously, I reached out to the Warden of Kershaw Correctional Institution, David Dunlap. Warden Dunlap responded to me in two separate emails, excerpts of which I have attached for the Court's information. Based on the information that Warden Dunlap provided, it does not appear that Appellant's legal materials were confiscated.

Looking in the automated system, I do show Campbell was searched by Kershaw staff on 4/1/15 and he was charged with a disciplinary (see below). Contraband Officer Jamar Harris was the accusing officer. I do not know if this involved the Agency Search team or was just a routine search. The narrative makes it sound like it was not the team.

I do also see a search by the AST on May 3rd involving the same inmate. See MIN below.

In neither case does it state anything about legal documents. I will have to follow up tomorrow with Contraband Staff to see if I can get specifics on what may have been taken.

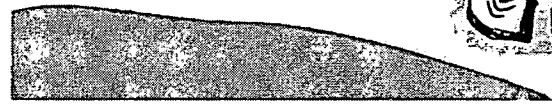
