ARGUMENTS AND AUTHORITIES

Pursuant to SCACR Rules 222 and 242 (j), Respondent Ann Dreher (Dreher) hereby requests that the Court tax costs against Petitioner South Carolina Department of Health and Environmental Control (DHEC) as set forth in the accompanying sworn statement.

Dreher appealed to the Court of Appeals from an adverse decision of the Administrative Law Court (ALC) upholding the denial by DHEC of her permit request. The Court of Appeals reversed the ALC and approved the permit. Following a motion by DHEC for Rehearing and Rehearing *en banc*, the Court of Appeals affirmed its earlier ruling.


DHEC then sought a writ of certiorari before the Supreme Court which was granted. Following briefing and arguments before the Supreme Court the decision of the Court of Appeals was affirmed as modified, and a motion for rehearing was denied. The matter was remitted to the ALC on June 18, 2015.

Dreher obtained a ruling before the Court of Appeals in her favor reversing the ALC decision. The decision of the Court of Appeals was upheld by the Supreme Court, and there is no order that costs not otherwise authorized be awarded.

CONCLUSION

Based on the foregoing, Respondent Ann Dreher respectfully requests that the Court award costs as set forth in the sworn statement of Christopher McG. Holmes.






