Dear Ms. Shealy:

Thank you for taking the time to speak with me this morning regarding our request for state court records. The Honorable Bristow Marchant, United States Magistrate Judge issued an order yesterday that the State is to provide the "complete record of all state court proceedings to date" for Mr. Bryant in anticipation of the filing of a federal habeas action. Such records must be filed with the District Court within 30 days of the date of the Order, or on or before July 24, 2015. While we have copies of many of the records, we are seeking actual file-stamped copies of briefs, petitions and records which may have further redactions than the copies maintained in our files. Pursuant to the Federal Rules, we may electronically file state court records without further redaction. We are attempting not only to provide the records, but also attempting to avoid accidental non-compliance with the District Court redaction rules by requesting copies of the actual documents received and maintained by the Court. These will not be further redacted under the federal rules. We are also striving for consistency in providing file-stamped copies from each action. I am not requesting documents such as opinions or orders that would not have the Court's stamp, or motions not going to the merits. I believe our copies will be sufficient for such other documents.

It is my understanding that I can send my assistant over to copy the scans onto a disc and we can save those copies for electronic filing then print paper copies for the federal court (also required) at our office. We hope to limit any inconvenience to you by obtaining the requested documents this way. If, for some reason, we need or are directed to obtain other such copies, I may need to revisit this request with you. However, I am attempting to limit the request to that which is necessary.

After our discussion this morning, I have reviewed our working list and would like to have stamped copies of the following:
