
**NOTICE OF MOTION AND MOTION

6. I believe that an extension of one business day, running through Monday, June 29, 2015, will afford sufficient time for me to complete the brief and designation.


7. The brief and designation otherwise would be due to be filed and served by mail today, and four previous extensions have been requested--most recently, for eight days on June 18, 2015.

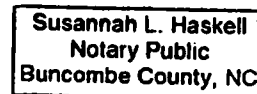



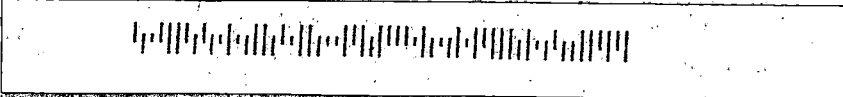
