MOTION TO REINSTATE

Appellant Ostendorff hereby moves this Court pursuant to Rule 260(a), of the South Carolina Appellant Court Rules, a MOTION TO REINSTATE, the above case.

The cause to need the appeal reinstated is that Appellant Ostendorff has a chronic allergy condition and mid-March through May have been unusually high in tree and grass pollen levels which has affected Ostendorff accordingly. 
Ostendorff is working to get caught up with other appeals also.
