

At a Court of General Sessions, convened on July 23, 2015, the Grand Jurors of York County present upon their oath:

**UNLAWFUL NEGLECT OF A CHILD**

The defendant, Jordan Tre'von Littlejohn, in York County, South Carolina, having charge or custody of a child, or being responsible for the welfare of the child, as defined by S.C. Code Ann. 63-7-20, did in York County on or about October 6, 2014, willfully and unlawfully place the minor victim at unreasonable risk of harm affecting the child's life, physical or mental health or safety or did unlawfully and maliciously cause bodily harm to the child so that the life or the health of the child was endangered or likely to be endangered and/or did willfully abandon the child. All in violation of 63-05-0070 of the South Carolina Code of Laws (1976) as amended.
