ON 7-16-14, I RECEIVED A MONEY ORDER FOR \$30.40; DUE TO MY OWNING THE STATE \$4,444.32, I WAS LEFT WITH A BALANCE OF \$6.41. I HAD ONLY \$1.41 TO SPEND AT THE CANTEN because medical had deducted \$5.02. FROM THE \$6.43, LEAVING A BALANCE OF \$1.41. SCDC IS IN VIOLATION OF AGENCY POLICY, ADM-15.12. COOPER TRUST FUND, BECAUSE MEDICAL ERRED IN USING THE FUNDS FROM MY ACCOUNT KNOWING THAT AN INDIGENT INMATE'S BALANCE OF \$6.43 AND UNDER SHOULD NOT BE USED IN ANY MANNER. PLEASE RETURN THE FUNDS.

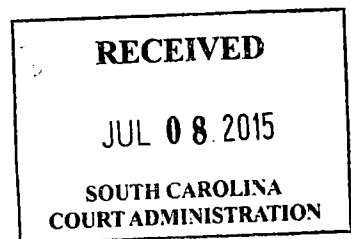

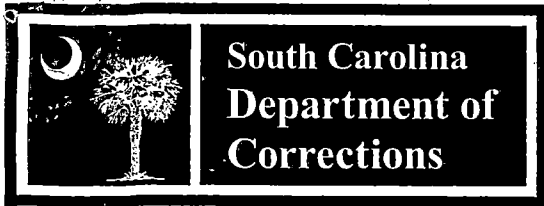


