I am in receipt of an Amended Notice of Appeal in the above referenced case. You will recall that I represented the Belton City Police Department and South Carolina Department of Motor Vehicles in this case. At the time I was involved, Anderson County 911 Service and the Anderson County Sheriff's Department were not named as defendants. I have reviewed the file at the Anderson County Clerk of Courts office and do not see that those entities were ever named as parties.

In any event, I filed a motion to dismiss which was granted by order filed July 21, 2014. That order dismissed the Belton City Police Department and South Carolina Department of Motor Vehicles as defendants. You did not appeal from that order.



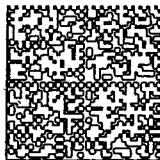
