**PETITION FOR EXTENSION TO FILE

Counsel filed the Anders brief of appellant and designation of matter along with the Record on Appeal in the case of State v. Phillip Helms in the Court of Appeals on June 1, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Duston L. Rogers in this Court on May 20, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Dervick L. Parker v. State in this Court on May 20, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Christopher J. Hicks in the Court of Appeals on May 12, 2015.



4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


WHEREFORE, the undersigned counsel would respectfully request a **final thirty-day extension, until August 12, 2015**, in which to file the petition for writ of certiorari and


