


AGREED DISMISSAL

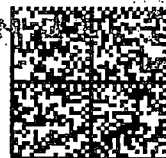
