We are in receipt of your letter dated June 29, 2015, regarding Mr. Anzelmo's June 16, 2015 letter. It is our understanding from Mr. Anzelmo's February 9, 2015, and June 16, 2015 letters that Appellants are in possession of the trial transcript but not in possession of the post-trial motion hearing transcript.
