Dear Mr. Powell:

I have received your letter of March 7, 2015, requesting a transcript of a hearing on November 5<sup>th</sup>, 2014, before The Honorable R. Markley Dennis.

Please review your records as to date of hearing and the case number. Only one hearing before The Honorable R. Markley Dennis on November 5, 2014, was on the record and the others were status conferences. Neither the name Jack Powell or Carolina Care is associated within any of those docketed cases. Further, a search of the records indicates Case Number 14-CP-10-6567 does not name Jack Powell or Carolina Center as parties.

Please let me know if there is another date that I can check for you.
