

ORDER

Appellant is attempting to appeal from an order of the probate court. Because the proper appellate forum is the circuit court, we transfer this case to the circuit court.¹ See S.C. Code Ann. § 62-1-308 (Supp. 2014) (providing appeals from the probate court are appropriate to the circuit court absent an exception); Rule 204(a), SCACR ("In the event that the notice of appeal is filed in the wrong appellate court, the appellate court in which the matter is filed shall issue an order transferring the case to the appropriate appellate court."); see e.g. *In re November 4, 2008 Bluffton Town Council Election*, 385 S.C. 632, 641, 686 S.E.2d 683, 688 (2009) (invoking Rule 204(a), SCACR, and transferring the case to the circuit court because it was the proper appellate forum).

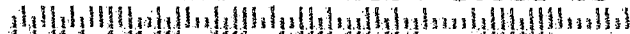
