
**MOTION TO FILE INITIAL BRIEF AND DESIGNATION OF MATTER



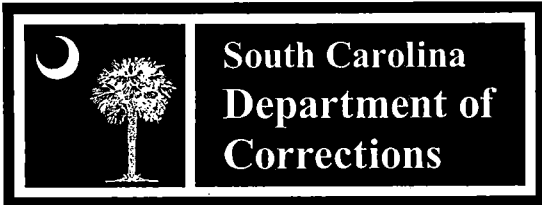


