
**MOTION TO ALLOW



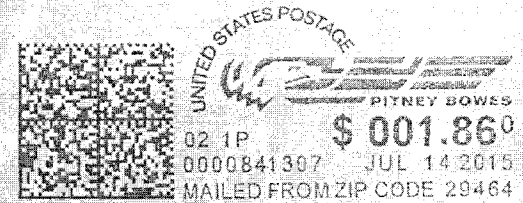
