
Enclosed is a Notice of Appeal in the above case. Also enclosed are the following:

- (1) Proof of service on Respondent.
- (2) A copy of the Order which is being challenged on appeal.
- (3) A copy of a Cooper Trust Fund Withdrawal slip showing that the Appellant initiated the process to obtain the \$100 filing fee on 06/27/15.

The Appellant asks that the Clerk file this Notice of Appeal, and allow for payment after SCDC supplies the check. This situation is above, and beyond, the Appellant's control. The process to obtain a check, and have it returned to the institution to be enclosed with the Notice, was initiated over two weeks ago. But, as of the last date for filing the Notice, SCDC has still not produced the check. The funds were deducted from the Appellant's EH Cooper Account on 06/27/15, and have not been refunded.

WRCI's Mailroom says that an EH Cooper check now "... takes 4 to 5 weeks. No matter who it's for." Essentially making it difficult, or next to impossible, to supply a filing fee within the 30 days allotted to file a Notice of Appeal.

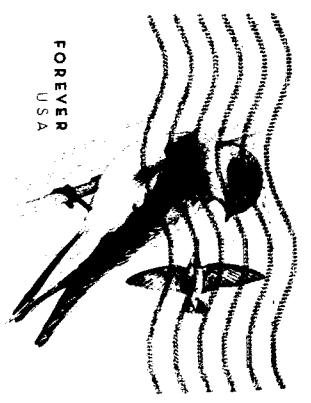
