
Thank you for your telephone call this morning, to let me know that two additional dates, September 15 and 17, 2015, have become available for the Court to hear oral argument in the above case. I respectfully request that argument not be scheduled on either of those dates, but rather on any of the dates previously identified, including September 8, 9, 10 and/or 11, 2015.

September 15, 2015 marks the second day of the Jewish holiday of Rosh Hashanah, and I will be unavailable as I will be attending religious services with my family at our synagogue.

It will be also be very difficult for me to prepare for argument on September 17 because I will be observing Rosh Hashanah from sundown on September 13 through September 15 and cannot do any work during this time. I will have a similar conflict on September 22-23 for the Jewish holiday of Yom Kippur.
