

State in this Court on June 12, 2015. Counsel argued in the case of Ruben Ramirez v. State in the Court of Appeals on June 10, 2015. Counsel filed the Anders brief of appellant and designation of matter along with the Record on Appeal in the case of State v. Phillip Helms in the Court of Appeals on June 1, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Duston L. Rogers in this Court on May 20, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Dervick L. Parker v. State in this Court on May 20, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


