Dear Mr. Shearouse:

I would like clarification regarding the status of the above referenced Petition for Certiorari, particularly my deadline (if required) for submitting a Return for said Petition.

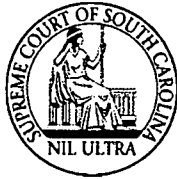
I object to the Clerk's leniency in granting extensions to the Petitioner for filing the Appendix, contrary to Rule 242(e) which states that the Appendix *shall* be filed at the same time the petition is filed. Our Court's Order dated July 16, 2014, states that only "upon a showing of good cause" may a party be granted extensions for filing a writ of certiorari *and appendix* under Rule 242. The Petitioner did not state any reasons for an extension (much less any "good cause" reasons as directed by our Court's Order). I object to your office summarily granting an extension, especially since I was never granted any opportunity to file a response to the Motion for Extension. Your Order dated June 23, 2015, grants Petitioner an extension until June 29, 2015, to "serve and file" the Appendix. I have never been served with an Appendix. I did recently receive a copy of a letter from Mr. Mogil to the Court, dated July 3, 2015, in which he apparently was "re-filing" an amended Appendix, which is certainly past your Order deadline of June 29.

I request that Petitioner's Writ for Certiorari be dismissed for failure to comply with Rule 242(e) and the Court's Order dated July 16, 2014. Should you feel that Petitioner has properly perfected the Writ of Certiorari, in full compliance with the Court's Rules and Orders, then I would like a clarification of the deadline for my Return to said Petition, and that my deadline be no sooner than thirty (30) days from the date that you deem the Writ and Appendix properly filed.

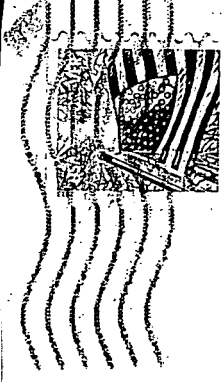
