
Appellant John Bradley Turner appeals Order Denying Petition For Writ of Mandamus by the Honorable Eugene C. Griffith, Jr. on July 7, 2015 and filed on July 10, 2015. The Appellant is presently confined in the South Carolina Department of Corrections after a plea of guilty to murder, possession of a firearm during the commission of a violent crime, trafficking methamphetamine, and manufacturing methamphetamine.

The issues for appeal are as follows:

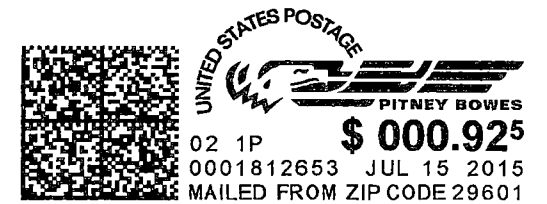
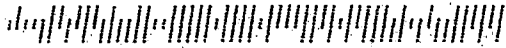
