

NOTICE OF APPEAL

Appellant Jenna Foran hereby appeals the South Carolina Workers' Compensation Commission Decision and Order dated July 14, 2015, on the grounds that the Commission erred by denying the claim, by concluding Appellant's injury was idiopathic and not a compensable injury, and by giving greater weight to the testimony of the employer's witness than to that of Appellant.



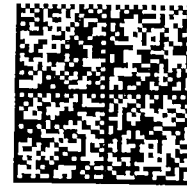
