Per your office's request, please allow this correspondence to serve as clarification for my recent filing of a "Corrected Designation of Matter to be Included on the Record on Appeal" in the above captioned matter.

Following the original filing of Respondent's Initial Brief and Designation of Matter, it was brought to our attention that certain inaccuracies were contained in our Designation. In our original designation we identified "Reply to Answer and Counterclaim" as an item to be included in the Record. However, a review of our file and the public index revealed that no such Reply was ever filed due to the prompt filing of an Amended Counterclaim by Petitioner. The Corrected Designation of Matter has removed that entry.

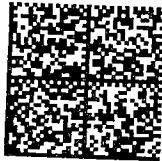

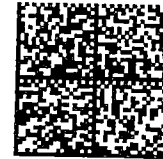
