
Respondent South Carolina Public Charter School District ("District" or "Respondent") hereby submits its Reply to Appellant's Return to the District's Motion to Dismiss. The grounds for the Motion to Dismiss are that Appellant, for the second time in this case, failed to adhere to this Court's Rules and Orders.

Specifically, by letters dated June 30, 2010, this Court directed Appellant to correct its Final Brief and Final Reply Brief within ten days. The filed final briefs included changes from the initial briefs and were replete with other errors. Moreover, the Record on Appeal filed by Appellants is riddled with errors and also includes confidential information of students that is not part of the Administrative Law Court's file. As set forth in the Motion to Dismiss, counsel for Respondent provided Appellant's counsel with the redacted version of the student records to file on May 20, 2015, but Appellant still has failed to correct the Record.

In its return, Appellant says it will make corrections needed, but it failed to do so within the time allowed by this Court and still has failed to do so as of the filing of this Reply. Therefore, the appeal should be dismissed.
