Please be advised that I received your letter, dated 07/23/15, and the returned check.


Mrs. Wilson refused to allow me to send a check directly to the SC Court of Appeals. Her failure to follow policy is being documented through the Grievance process as well.

Please find enclosed an Affidavit that I wish to have made part of the permanent record in connection with this appeal. I am serving SCDC's Office of General Counsel with a copy as well. For clarification's sake, I will be submitting this letter and the Affidavit after having someone other than Mrs. Wilson notarize the Affidavit. I requested notary services with an ARTSM today, and will have to wait for a response.

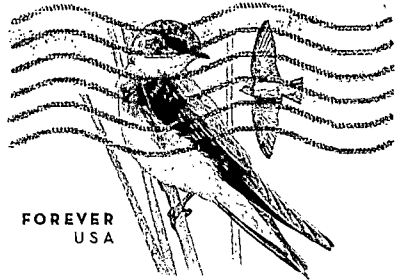
