
Dear Mr. Shearouse:

We have resolved issues involving the Record on Appeal based on an agreement that if a party argues the absence of evidence in the record of parishes' title to real property or absence of evidence on the issue of the parishes' votes to modify their governance documents means anything or if the Court points to the absence of this information or needs/wants to see this evidence for any reason, the parties agree in advance they will jointly move to supplement the record with the information. This will substantially reduce the size of the Record on Appeal.

Additionally, there is still some similar parish witness testimony in the Record on Appeal which remains because of logistics issues related to the preparation of the record. Except where the parties specifically reference portions of this testimony in their briefs, there is no need for the Court to review the entirety of the testimony beginning with the witness, Hodge, R p. 240 and ending with the witness Zimmerman, R p. 658.
