

STATEMENT PURSUANT TO RULE 203(d)(1)(B)(iv)

Anthony James appeals His guilty plea and sentence in the aforementioned cases. Appellant pled guilty on June 23, 2015, to Criminal Domestic Violence, 2nd offense. The State recommended a sentence of one year, suspended to time served followed by probation with special condition that he complete counseling.

The plea court accepted Appellant's guilty plea, and imposed the recommended of one year, suspended upon service of time served followed by two (2) years probation with special condition that Appellant complete counseling. Undersigned counsel is filing this appeal at the request of Appellant, and pursuant to State v. Thrift, 378 S.C. 70, 661 S.E.2d 373 (2008), Weathers v. White, 319 S.C. 59, 459 S.E.2d 838 (1995), and In re Anonymous Member of the Bar, 303 S.C. 306, 400 S.E.2d 483 (1991). Although Counsel asserts this filing is timely pursuant to Rule 263, SCACR (the tenth day fell on July 3, 2015—a State Holiday—and July 6, 2015 is the first available day thereafter to file), Counsel knows of no issue that can be reviewed on direct appeal.



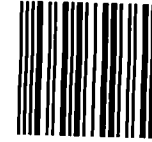
