**RESPONDENTS' RETURN TO APPELLANT'S
MOTION FOR REVIEW OF TRANSCRIPT CHALLENGES**


The Appellant Karen Oliver has filed yet another motion related to the transcript of the October 9, 2013 motion hearing that she received from the court reporter, Mona Manley. The Appellant has filed multiple motions previously challenging the accuracy of the transcript, and those motions have all been denied by this Court by way of Orders filed November 10, 2014 and February 20, 2015. The Appellant has also re-asserted the issue in her Initial Brief. There is simply no basis for the relitigation of those rulings.

The record reflects that the court reporter timely responded to the Appellant's requests by confirming the accuracy of the transcript as prepared. Upon information and belief, the Appellant has never made a written request to Judge J.C. Nicholson nor made any showing of "good cause" for his review of the transcript. Furthermore, it is apparent that the Appellant's "specific challenges" to the transcript, even if accurate, are inconsequential and have no material effect on this appeal and the legal issues as asserted – which is further addressed in the Respondents' response brief. In sum, the issues that the Appellant raises with respect to the transcript serve as no basis for the reversal of Judge Nicholson's ultimate adjudication of this case or for a rehearing on the Appellant's motion for reconsideration.

Therefore, the Court is respectfully submitted to deny this duplicative motion filed by the Appellant.


