COME NOW Betty Fisher and Lisa Fisher, Appellants in the above appeals, and,
pursuant to Rule 263(b), SCACR, move for an extension of time to file and serve the
Consolidated Record on Appeal until 30 days after this Court's ruling on Appellants' Joint
Motion to Strike Portions of Respondent's Designation of Record.

By Orders of March 9, 2015 the Record on Appeal for the above 3 appeals were ordered

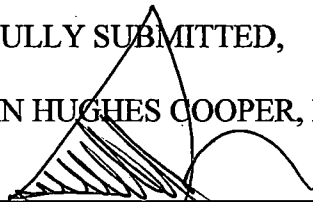
WHEREFORE, Appellants pray for an Order allowing 30 days after the ruling on the pending Motion to Strike for Appellants to file and serve the Record.

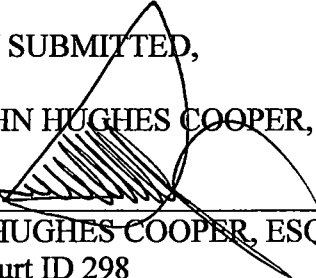
