Undersigned counsel for Respondents Ocwen Loan Servicing, LLC ("Ocwen") American and Home Mortgage Servicing, Inc. a/k/a Homeward Residential ("Homeward") hereby move before this Court for an Order requiring the Appellant, Neva Steffens, to supplement the Record on Appeal to include all items listed in Respondents' Designation of Matter to be Included in the Record on Appeal filed June 30, 2015.

The grounds for this motion is that without such supplementation, Respondents are unable to properly cite to the Record on Appeal as required by Rule 211(b)(1) SCACR, and this Court will not have at its disposal all of the relevant and pertinent materials it might require in order to decide this appeal.

Specifically, Appellant failed to include the following documents identified in Respondents' Designation of Matter on Appeal: Complaint; Respondents' Answer and Affirmative Defenses; Entire Transcript of Court Proceedings on October 13-14, 2014; Defendants' Trial Exhibit 6 (Homeward Transaction History) and Defendants' Trial Exhibit 7 (Ocwen Transaction History). All the aforementioned items that Appellant omitted are material and necessary elements of the Record.

Further, in regard to Defendants' Trial Exhibit 1, the Note and Mortgage, R. pp. 177-195, in the Record on Appeal filed by Appellant, pages 963-964 of Book 4503 are missing. Page 963 reflects Appellant's signature on the Mortgage; page 964 is the Notary signature page. Pages 963 and 964 should be required to be included in the Record.


