
MOTION



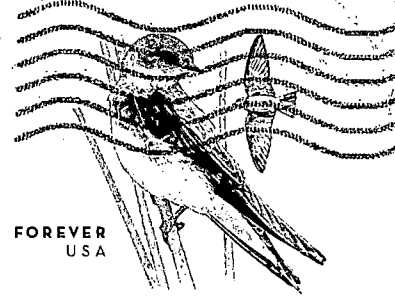

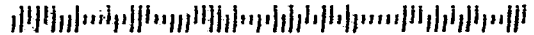
