
Dear Ms. Kitchings:

I write to respond to your letter dated August 5, 2015. Prior to filing our Notice of Appeal, we ordered and received all transcripts pertinent to this appeal. We will not need to move to order the transcript outside of the deadline set forth in Rule 207 of the South Carolina Appellate Court Rules.

On December 18, 2013, we ordered the transcript of the October 23, 2012 hearing. We ordered and received the transcript of the first trial of this matter in February of 2014.
