The parties have all agreed to allow the Department's intervention in this action and have all agreed to the remand of the case to the Seventh Judicial Circuit Court for a ruling on the


Department's April 3, 2015, Motion to Intervene and Reconsider the Court's Order of March 27, 2015.

WHEREFORE, based upon the foregoing, it is ordered that this matter is remanded to the Seventh Judicial Circuit Court.




