Dear Elizabeth:

On Monday, July 23, 2012, you and I spoke about the record on appeal we filed with the Court. In that conversation, you indicated two main things that needed addressing and/or fixing: (1) you needed an original proof of service and an original certificate of counsel and (2) you needed an explanation for the indexers that were included in our filed record on appeal.

In putting together the record on appeal, I mirrored the record on appeal that was filed with the Administrative Law Court, which included five indexers. Based on my conversation with you, I understand that the indexers are two big, according to the rules, therefore, for purposes of scanning the record on appeal into the Court of Appeals computer system, it is unnecessary to also scan the pages with the indexers because those pages do not contain any content or evidence in the record that a judge on the Court of Appeals would need to review. I believe that not scanning the five pages with indexers will solve any problem with the page size limit and the rule concerning it.


