

**RESPONDENT'S MOTION FOR EXTENSION
OF TIME TO FILE ITS BRIEF**

Pursuant to Rule 240 of the South Carolina Rules of Appellate Practice, Respondent Virgil Hoff moves this Court for an Order granting an extension of time during which to file its Brief in response to the Initial Brief of the Appellant filed on August 10, 2015. 
