

Counsel filed an initial brief of appellant in the case of In the Matter of the Care and Treatment of Daquan Johnson with this Court on July 23, 2015. Counsel filed a petition for writ of certiorari to the Court of Appeals in the case of The State v. John Edward Haynes with the Supreme Court on July 22, 2015. Counsel filed a petition for writ of certiorari in the case of The State v. Anthony Jackson with the United States Supreme Court on July, 7, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of In the Matter of the Care and Treatment of Jeffrey Allen Chapman with this Court on July 1, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Blaton Wakeem Smith with this Court on June 29, 2015. Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of State v. Akeem O. Smith with the Supreme Court on June 22, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by the consent below, counsel for the state graciously consents to or does not oppose this request.


