
I, Loushonda Myers, now petitions the Court for an extension of time to make an agreement with the court reporters to order and pay for transcripts. I am requesting this extension for good cause as follows:

1. The Order sent to me was dated August 13, 2015. In this order, Jasper (illegible)[unknown relation to Court], stated, "Within ten days of the date of this order, Appellant shall provide proof the transcript has been ordered, including any agreement regarding payment of the transcript pursuant to Rule 207 (a)(1), SCACR;
 - a. I received and was notified of this Order on August 21, 2015. I was not within the States at the time that this order was sent. (I was on a cruise.) My family and I were on a planned family vacation, financed and coordinated by my father.
2. My motion was submitted to this Court on or around mid-May 2015; and I had no way of knowing when a ruling and/or order was to be made on the matter;

3. There are two court reporters involved in this matter. Both court reporters are contacted by USPS mail; and I will need time for their receipt of my request, as well as a response;
4. I have written both Court Reporters and have requested that a copy of the transcripts be produced. These letters will be mailed out on Monday, August 24, 2015. A copy of each letter has been attached;
5. I am requesting this extension for just cause and not for the purposes of delay;
6. I have provided proof to the Court that after being notified and aware of the Order, I acted promptly; and
7. As shown by the attached letters, I have attempted to make reasonable agreements with the Court Reporters to obtain the transcripts.

Therefore, I am asking the Court for an extension of time to and including September 4, 2015, in order to make arrangements with the Court Reporters for the production of the transcripts.

I have previously contacted you in regards to obtaining a copy of the court transcript from September 26, 2014 (Judge Kristi Lea Harrington).


I am now requesting a copy of that transcript to be produced.
