THANKS FOR YOUR HELP, AND KEEPING ME INFORMED OF MY LEGAL OBLIGATION IN THIS APPEAL.

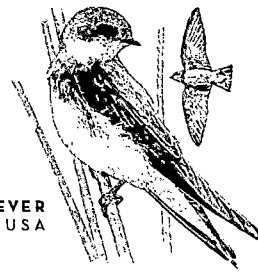

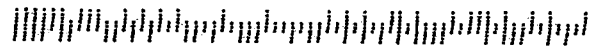
